PURPOSE

In accordance with Section 255.20, *Florida Statutes*, and other state and federal laws, The Board of Trustees of Bay Medical Center, a special district, (the “**District**”) is soliciting proposals from qualified general contractors to repair the roof and exterior of the North Central Energy Plant on its hospital campus at 615 North Bonita Avenue, Panama City, Florida that was damaged by Hurricane Michael.

SCHEDULE

The following dates and activities are provided for planning purposes. All proposers who submit proposals by the submission deadline will be notified of any changes in writing.

Short listing and follow up presentations are not expected to be needed. Proposers should be prepared to answer follow up questions by phone as needed in the afternoon on Monday, July 27, 2020. If presentations are needed, the District will notify selected proposers of the timing and location of the presentations.

SCOPE OF WORK

Background. The District owns health care facilities in the Florida panhandle. On October 10, 2018, Hurricane Michael severely damaged the District’s health care facilities, and the District requires repairs to the North Central Energy Plant Roof and Exterior so it can continue to provide critical community health services. Repairs and restoration may include exterior repairs, window replacement, roofing, and other repairs and restorations. The District seeks to secure the services of a qualified general contractor with proper equipment and a team of experienced personnel who can restore and repair the buildings according to the project specifications. The selected contractor must also work cooperatively with District, Lessee, state and federal grant professionals during the construction process. The estimated budget for this project is at least \$500,000 dollars.

Required Personnel and Resources. The respondent shall have demonstrated experience as a general contractor on a large multi-story building. Health care experience, knowledge of Agency for Health Care Administration (“**AHCA**”) facility construction rules and regulations, and knowledge of Infection Control Risk Assessment (“**ICRA**”) construction standards are preferred. Since the

primary service required is construction and contracting services, the firm must be a licensed general contractor in the State of Florida.

Scope of Work. The scope of work for this proposal is set forth in the attached North Central Energy Plant Exterior Repairs and Roof Coating specifications drafted by GMC Architects (the “**Scope of Work**”). The work shall also be performed in accordance with state and federal disaster grant requirements. This is an open bid, and any applicant who meets the minimum qualifications and is interested in the work is encouraged to apply. If in doubt about bidding requirements or the Scope of Work, please contact the District as described in the Pre-Submittal section below. Time is of the essence for this project. Applicants must be ready to mobilize and start work quickly.

Health Care Experience Preferred. Preference will be given to firms with demonstrated experience in the health care industry, health care disaster recovery, and AHCA and ICRA construction requirements.

Respondents may be asked to submit their questions in writing.

Contractors or entities desiring to provide proposals, as described in the Scope of Work, shall submit sealed proposals with an original, five (5) complete copies, and one (1) electronic copy by CD or flash drive with all the required information below included (each document must be in an individual PDF format file) no later than 1:00 p.m., central time, July 27, 2020 to Bay Health Foundation in person or by courier at 11 Harrison Avenue, Unit E, Panama City, Florida 32401.

Qualifications shall be sealed, and submitter should indicate on their proposal the following:

Offers by telephone or telegram shall not be accepted. Also, submitters are instructed NOT to fax their qualifications. Faxed qualifications shall be rejected as non-responsive regardless of where or when the fax is received. Due to COVID-19, electronic submission is also available. Please contact the District for electronic submission procedures.

Respondents are cautioned that they are responsible for delivery to the specific location cited above. Therefore, if your qualifications are delivered by an express mail carrier or by any other

means, it is your responsibility to ensure delivery to the above address. This office will not be responsible for deliveries made to any place other than the specified address.

It is the sole responsibility of the service provider to ensure that their proposal reach the District on time. The District shall not be responsible for late deliveries or courier delays. All proposals will be opened publicly.

INSURANCE REQUIREMENTS

A minimum coverage of Professional Liability Insurance, Workers' Compensation Insurance, Commercial General Liability Insurance, and Business Automobile Liability Insurance will be required. Insurance is to be placed with insurers with a Best's rating (or equivalent rating agency) of no less than A. Proposals shall include Builder's Risk coverage in their proposal, with the costs of such provided as an alternative bid. Evidence of insurance shall be provided to the District prior to mobilization to the hospital campus, and the respondent shall provide for thirty-day notice in writing to the District prior to cancellation, expiration, or non-renewal of any insurance. Please see attached AIA A010-2017 Exhibit A for specific insurance and bond requirements for this project.

Additional Insureds

All insurance required by this contract (excluding only Workers Compensation Insurance and Professional Liability Insurance) shall name Indemnified Parties as Additional Insureds and any other parties as required by the Owner Contract, and shall be primary and non-contributory to any insurance maintained by Indemnified Parties and Additional Insureds and any other parties as required by Owner Contract, all of which shall be stated on the Certificate of Insurance provided by the contractor.

The General Liability Additional Insured Endorsement shall use ISO's CG 2010 or its substantial equivalent for ongoing operations and ISO's CG 2037 or its substantial equivalent for completed operations. Evidence, by endorsement or policy language, of Additional Insured and Primary and Non-Contributory coverage must be provided with the certificate of insurance for General Liability.

Claims-Made Policies

Except for Professional and Pollution Liability Insurance, claims-made policies are not acceptable.

TERMS AND CONDITIONS

Project Specific

- a. Provide all necessary labor, materials, tools, equipment to successfully complete the project.
- b. Contractor will maintain project logs for Potential Change Orders (PCO) and Change Orders (CO). All monthly billings must be emailed to the Owner's Representative or design Consultant for approval as directed by the Owner. Contractor must provide backup documentation to validate the cost of all potential change orders and change orders. Cost documentation shall include subcontractor cost, materials costs, hourly personnel cost including labor burden plus the agreed markup fee. Contractor must also provide necessary documentation supporting the purpose for all added cost that can be classified for example as Constructability, Field conditions Design Change, Owner Preferences, Regulatory Compliance.

- c. Contractor will be responsible for generating Requests for Information (RFI), Submittals and Meeting Minutes for the duration of the project if requested by the Owner's representative. Submittal and RFI logs will be kept by the Contractor for regular review.
- d. Closeout documents will be required as stated in the design documents. If there are no design documents, the Contractor will still must provide the minimum of a one-year warranty from the date of substantial completion for equipment and labor and, equipment and maintenance manuals.
- e. Final billings will not be submitted for payment until all required closeout information is provided to the Owner, and all punch list issues are resolved. If there is not a Consultant for the project, the Contractor shall provide the closeout information requested by the Owner's representative.
- f. Contractor shall provide a detailed schedule of milestones, deliveries and inspections required to the completion of the project and shall update the schedule as dates are delayed or advanced.
- g. Contractor must have a team member on site at all times with Occupational Safety and Health Administration (OSHA) 30-hour training.
- h. Any other requirement as stated in the Scope of Work.

General

1. The District reserves the right to accept or reject any or all proposals, with or without cause, to waive technicalities, or to accept the qualification which, in its sole judgment, best serves the interest of the District, or to award a contract to the next most qualified submitter if a successful submitter does not execute a contract within thirty (30) days after approval of the selection by the District.
2. The District reserves the right, and has absolute and sole discretion, to cancel a solicitation at any time prior to approval of the award by the District.
3. The District reserves the right to request clarification of information submitted and to request additional information of one or more applicants.
4. Any firm may withdraw from consideration at any time in writing prior to award of the contract.
5. Costs of preparation of a response to this request for proposals are solely those of the submitter. The District assumes no responsibility for any such costs incurred by the submitter. The submitter also agrees that the District bears no responsibility for any costs associated with any administrative or judicial proceedings resulting from the solicitation process.
6. A person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a bid, proposal, or reply on a contract with a public entity for the construction or repair of a public building or public work; may not submit bids, proposals, or replies on leases of real property to a public entity; may

not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity; and may not transact business with any public entity in excess of the threshold amount provided in s. 287.017 for CATEGORY TWO for a period of 36 months following the date of being placed on the convicted vendor list.

7. Consultants shall not discriminate against any employee or applicant for employment because of race, color, religion, sex, age, or national origin. Consultants should ensure that minority and disadvantage applicants are represented in their workplace and employees are treated during their employment without regard to race, color, religion, sex, age, or national origin.
8. The respondent understands that this RFP does not constitute an agreement or contract with the District. After selection, the District will negotiate a contract with the respondent with the highest ranked proposal, and if unable to agree upon a contract, the District, at its option, can terminate negotiations and begin negotiations with the respondent with the next highest ranked proposal.
9. Any contractor or entity, who submits in its proposal any information that is determined by the District to be substantially inaccurate, misleading, exaggerated, or incorrect, may be disqualified from consideration.
10. The contractor or entity awarded this contract shall maintain adequate records to justify all charges, expenses, and costs incurred in estimating and performing the work for at least three (3) years after completion of the later of final grant closeout or final audit by OMB of any project work performed under contract resulting from this RFP. The District shall have access to all records, documents and information collected and/or maintained by others in the course of the administration of the agreement. This information shall be made accessible at the awardees place of business to the District, including the Comptroller's Office or its designees, for purposes of inspection, reproduction and audit without restriction.
11. Any respondent who is deemed to have a conflict of interest prohibited by Chapter 112, Florida Statutes or by any generally accepted rules of professional conduct for professional engineers shall be disqualified.
12. The District is an independent special district of the State of Florida and is subject to Florida's broad public records law. The respondent shall comply with Florida's Public Records Act, Chapter 119, Florida Statutes. If the respondent is determined to be acting on behalf of the District as provided under Section 119.011(2), *Florida Statutes*, the respondent shall specifically comply with all its requirements, which shall be incorporated into any final contract between the District and respondent.
13. The successful respondent shall comply with all state and federal grant contracting requirements, including, but not limited to, an anti-collusion clause, a drug-free workplace certification, certification regarding state and federal lobbying, a certification that the respondent has not been debarred, suspended, or is otherwise ineligible or excluded from federal or state contracting, and an agreement to comply with other state and federal grant contract regulations.

EVALUATIONS OF PROPOSALS

Selection shall be in accordance with Section 255.20, *Florida Statutes*, FEMA regulations, and other state and federal laws. Minimum requirements to qualify:

- The prime contractor must be a licensed general contractor in the State of Florida.
- The contractor shall provide its qualifications and capabilities that demonstrate how the contractor will provide the restoration services as outlined within the Scope of Work. Highlight any past experience as the prime contractor with a federal emergency disaster recovery grant. The following should be provided on the attached forms or in the respondent's submission:

Relevant Experience - Recent experience demonstrating current capacity and expertise in restoring large multi-story buildings, preferably in health care facilities or after a federally declared disaster. Knowledge & Experience with AHCA and ICRA construction standards is critical and should be included. Also, highlight any experience in restoring partially occupied buildings.

Past Performance on Similar Projects - Provide at least three (3) references for which the firm has performed restoration or health care construction work, preferably in similar circumstances to this project or Scope of Work. Provide the reference contact name, address, e-mail address, telephone numbers and date of the contract.

Projected Schedule and Current Workload - Provide a projected schedule to complete the Project and your current workload and availability of key personnel.

- The respondent should describe its approach and methodology to accomplish the Scope of Work in the time projected in the schedule. The description shall include information on anticipated manning for the project and any other information the respondent would like the District to consider.
- The respondent shall complete all required forms and certifications in this RFP.
- The respondent shall provide a list of any contract document revisions suggested or required by the respondent from the draft AIA contracts documents provided in this RFP for review.

The vendor shall disclose the name of any officer, director, employee, or other agent who is also an employee of the State. Grantee shall also disclose the name of any State employee who owns, directly or indirectly, more than a five percent (5%) interest in the Contractor's company or its affiliates.
- 2 Discriminatory Vendors** – (1) No person, on the grounds of race, creed, color, religion, national origin, age, gender, or disability, shall be excluded from participation in; be denied the proceeds or benefits of; or be otherwise subjected to discrimination in performance during the term of the contract. (2) Contractor shall disclose if they appear on the discriminatory vendor list. An entity or affiliate placed on the discriminatory vendor list pursuant to section 287.134, F.S. may not: 1) Submit a bid on an agreement to provide any goods or services to a public entity; 2) Submit a bid on an agreement with a public entity for the construction or repair of a public building or public work; 3)Submit bids on leases of real property to a public entity; or 4) Be

awarded or perform work as a consultant under an agreement with any public entity; or transact business with any public entity.

3. **Lobbying** - No funds received pursuant to this Agreement may be expended for lobbying the Federal or State Legislature, the judicial branch, or a federal or state agency. (2) If any funds other than Federal appropriated funds have been paid or will be paid to any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with this Federal contract, grant, loan, or cooperative agreement, the undersigned shall complete and submit Standard Form-LLL, "Disclosure Form to Report Lobbying," in accordance with its instructions. (3) The undersigned shall require that the language of this certification be included in the award documents for all sub-awards at all tiers (including subcontracts, sub-grants, and contracts under grants, loans, and cooperative agreements) and that all sub- recipients shall certify and disclose accordingly.

This certification is a material representation of fact upon which reliance was placed when this transaction was made or entered into. Submission of this certification is a prerequisite for making or entering into this transaction imposed by section 1352, title 31, U.S. Code. Any person who fails to file the required certification shall be subject to a civil penalty of not less than \$10,000 and not more than \$100,000 for each such failure

4. **Record Retention** – A. The contractor shall maintain and retain sufficient records demonstrating its compliance with the terms of the Agreement for a period of at least five (5) years after final payment is made and shall allow the County, the State, or its authorized representatives access to such records for audit purposes upon request. B. In the event of litigation or settlement of claims arising from the performance of this contract, in which case contractor agrees to maintain same until the County, the FEMA Administrator, the Comptroller General of the United States, or any of their duly authorized representatives, have disposed of all such litigation, appeals, claims or exceptions related to the litigation or settlement of claims
5. **Diversity** – All contracting and subcontracting opportunities afforded by this solicitation/contract embrace diversity enthusiastically. The award of subcontracts should reflect the full diversity of the citizens of the State of Florida. Firms qualifying under this solicitation are encouraged to submit bids/proposals. Award of this contract

will be conditioned upon satisfying the requirements of this bid specification. These requirements apply to all bidders/offerors, including those who qualify as a Minority Business vendor. A list of minority owned firms that could be offered subcontracting opportunities may be obtained by contacting the Office of Supplier Diversity at (850) 487-0915.

6. **Applicable Laws** - The contractor shall comply with all applicable federal, state and local rules and regulations in providing services to the County. The contractor acknowledges that this requirement includes, but is not limited to, compliance with all applicable federal, state and local health and safety rules and regulations and that FEMA financial assistance may be used to fund the contract. As such, the contractor will comply with all applicable federal law, regulations, executive orders, FEMA policies, procedures, and directives.
7. **Administrative, Contractual, or Legal Remedies** - Unless otherwise provided in this contract, all claims, counter-claims, disputes and other matters in question between the local government and the contractor, arising out of or relating to this contract, or the breach of it, will be decided by arbitration, if the parties mutually agree, or in a Florida court of competent jurisdiction.
8. **Termination for Cause and for Convenience** - This contract may be terminated in whole or in part in writing by either party in the event of substantial failure by the other party to fulfill its obligations under this contract through no fault of the terminating party, provided that no termination may be effected unless the other party is given: (a) Not less than ten (10) calendar days written notice (delivered by certified mail, return receipt requested) of intent to terminate; and (b) An opportunity for consultation with the terminating party prior to termination.

This contract may be terminated in whole or in part in writing by the local government for its convenience, provided that the other party is afforded the same notice and consultation opportunity specified in I (a) above. If termination for default is effected by the local government, an equitable adjustment in the price for this contract shall be made, but no amount shall be allowed for anticipated profit on unperformed services or other work, and any payment due to the contractor at the time of termination may be adjusted to cover any additional costs to the local government because of the contractor's default.

If termination for convenience is effected by the local government, the equitable adjustment shall include a reasonable profit for services or other work performed for which profit has not already been included in an invoice. For any termination, the equitable adjustment shall provide for payment to the contractor for services rendered and expenses incurred prior to receipt of the notice of intent to terminate, in addition to termination settlement costs reasonably incurred by the contractor relating to commitments (e.g., suppliers, subcontractors) which had become firm prior to receipt of the notice of intent to terminate.

10. **Clean Air Act and Federal Water Pollution Control Act** - (1) The contractor agrees to comply with all applicable standards, orders or regulations issued pursuant to the Clean Air Act, as amended, 42 U.S.C. § 7401 *et seq.* (2) The contractor agrees to comply with all applicable standards, orders or regulations issued pursuant to the Federal Water Pollution Control Act, as amended, 33 U.S.C. 1251 *et seq.* (3) The contractor agrees to report each violation to the County and understands and agrees that the County will, in turn, report each violation as required to assure notification to the Federal Emergency Management Agency, and the appropriate Environmental Protection Agency Regional Office. (4) The contractor agrees to include these requirements in each subcontract exceeding \$100,000 financed in whole or in part with Federal assistance provided by FEMA.

11. **Suspension and Debarment** (1) This contract is a covered transaction for purposes of 2 C.F.R.pt. 180 and 2 C.F.R. pt. 3000. As such the contractor is required to verify that none of the contractor, its principals (defined at 2 C.F.R. § 180.995), or its affiliates (defined at 2 C.F.R. § 180.905) are excluded (defined at 2 C.F.R. § 180.940) or disqualified (defined at 2 C.F.R. § 180.935). (2) The contractor must comply with 2 C.F.R. pt. 180, subpart C and 2 C.F.R. pt. 3000, subpart C and must include a requirement to comply with these regulations in any lower tier covered transaction it enters into. (3) This certification is a material representation of fact relied upon by the County. (4) The bidder or proposer agrees to comply with the requirements of 2 C.F.R. pt. 180, subpart C and 2 C.F.R. pt. 3000, subpart C while this offer is valid and throughout the period of any contract that may arise from this offer. The bidder or proposer further agrees to include a provision requiring such compliance in its lower tier covered transactions." 12. Reporting - The contractor will provide any information required to comply with the grantor agency requirements and regulations pertaining to reporting. It is important that the contractor is aware of the reporting requirements of the County, as the Federal or State granting agency may require the contractor to provide certain information, documentation, and other reporting in order to satisfy reporting requirements to the granting agency.

13. Access to Records – (1) The contractor agrees to provide the County, the FEMA Administrator, the Comptroller General of the United States, or any of their authorized representatives access to any books, documents, papers, and records of the Contractor which are directly pertinent to this contract for the purposes of making audits, examinations, excerpts, and transcriptions. (2) The Contractor agrees to permit any of the foregoing parties to reproduce by any means whatsoever or to copy excerpts and transcriptions as reasonably needed. (3) The contractor agrees to provide the FEMA Administrator or his authorized representatives' access to construction or other work sites pertaining to the work being completed under the contract.”

Pursuant to Section 20.055(5), F.S., the contractor will cooperate with the State of Florida's Inspector General in any investigation, audit, inspection, review, or hearing.

14. Energy Efficiency Standards - The contractor agrees to comply with mandatory standards and policies relating to energy efficiency which are contained in the state energy conservation plan issued in compliance with the Energy Policy and Conservation Act.

15. DHS Seal, Logo, and Flags - “The contractor shall not use the DHS seal(s), logos, crests, or reproductions of flags or likenesses of DHS agency officials without specific FEMA pre- approval.”

16. No Obligation by Federal Government - The Federal Government is not a party to this contract and is not subject to any obligations or liabilities to the non-Federal entity, contractor, or any other party pertaining to any matter resulting from the contract.

17. Program Fraud and False or Fraudulent Statements or Related Acts - The contractor acknowledges that 31 U.S.C. Chap. 38 (Administrative Remedies for False Claims and Statements) applies to the contractor's actions pertaining to this contract.”

18. Recovered Materials –

(1) In the performance of this contract, the Contractor shall make maximum use of products containing recovered materials that are EPA designated items unless the product cannot be acquired (i) Competitively within a timeframe providing for compliance with the contract performance schedule; (ii) Meeting contract performance requirements; or (iii) At a reasonable price.

19. Discriminatory Vendors List: In accordance with Section 287.134, Florida Statutes, an entity or affiliate who has been placed on the discriminatory vendor list may not submit a bid on a contract to provide any goods or services to a public entity, may not submit a bid on a contract with a public entity for the construction or repair of a public building or public work, may not submit bids on leases of real property to a public entity, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity.

20. Inspector General Cooperation: The Parties agree to comply with Section 20.055(5), Florida Statutes, for the inspector general to have access to any records, data and other information deemed necessary to carry out his or her duties and incorporate into all subcontracts the obligation to comply with Section 20.055(5), Florida Statutes.

21. Contracting With Small And Minority Businesses, Women's Business Enterprises, And Labor Surplus Area Firms

(a) The non-Federal entity must take all necessary affirmative steps to assure that minority businesses, women's business enterprises, and labor surplus area firms are used when possible.

(b) Affirmative steps must include:

24. Compliance With Copeland “Anti-Kickback” Act

(1) Contractor. The contractor shall comply with 18 U.S.C. § 874, 40 U.S.C. § 3145, and the requirements of 29 C.F.R. pt. 3 as may be applicable, which are incorporated by reference into this contract.

(2) Subcontracts. The contractor or subcontractor shall insert in any subcontracts the clause above and such other clauses as the FEMA may by appropriate instructions require, and also a clause requiring the subcontractors to include these clauses in any lower tier subcontracts. The prime contractor shall be responsible for the compliance by any subcontractor or lower tier subcontractor with all of these contract clauses.

(3) Breach. A breach of the contract clauses above may be grounds for termination of the contract, and for debarment as a contractor and subcontractor as provided in 29 C.F.R. § 5.12.

25. Contract Work Hours And Safety Standards Act 40 U.S.C. 3702 And 3704, As Supplemented By Department Of Labor Regulations (29 CFR Part 5)
Compliance with the Contract Work Hours and Safety Standards Act.

(1) Overtime requirements. No contractor or subcontractor contracting for any part of the contract work which may require or involve the employment of laborers or mechanics shall require or permit any such laborer or mechanic in any workweek in which he or she is employed on such work to work in excess of forty hours in such workweek unless such laborer or mechanic receives compensation at a rate not less than one and one-half times the basic rate of pay for all hours worked in excess of forty hours in such workweek.

(2) Violation; liability for unpaid wages; liquidated damages. In the event of any violation of the clause set forth in paragraph (1) of this section the contractor and any subcontractor responsible therefor shall be liable for the unpaid wages. The County shall upon its own action or upon written request of an authorized representative of the Department of Labor withhold or cause to be withheld, from any moneys payable on account of work performed by the contractor or subcontractor under any such contract or any other Federal contract with the same prime contractor, or any other federally-assisted contract subject to the Contract Work Hours and Safety Standards Act, which is held by the same prime contractor, such sums as may be determined to be necessary to satisfy any liabilities of such contractor or subcontractor for unpaid wages and liquidated damages as provided in the clause set forth in paragraph (2) of this section.

26. Rights To Inventions Made Under A Contract Or Agreement

If the Federal award meets the definition of "funding agreement" under 37 CFR § 401.2 (a) and the recipient or subrecipient wishes to enter into a contract with a small business firm or nonprofit organization regarding the substitution of parties, assignment or performance of experimental, developmental, or research work under that "funding agreement," the recipient or subrecipient must comply with the requirements of 37 CFR Part 401, "Rights to Inventions Made by Nonprofit Organizations and Small Business Firms Under Government Grants, Contracts and Cooperative Agreements," and any implementing regulations issued by the awarding agency.

Byrd Anti-Lobbying Amendment, 31 U.S.C. § 1352 (as amended). Contractors who apply or bid for an award of \$100,000 or more shall file the required certification. Each tier certifies to the tier above that it will not and has not used Federal appropriated funds to pay any person or organization for influencing or attempting to influence an officer or employee of any agency, a member of Congress, officer or employee of Congress, or an employee of a member of Congress in connection with obtaining any Federal contract, grant, or any other award covered by 31 U.S.C. § 1352. Each tier shall also disclose any lobbying with non-Federal funds that takes place in connection with obtaining any Federal award. Such disclosures are forwarded from tier to tier up to the recipient.
